一、引言

A. Introduction

為促進數據在粵港澳大灣區內安全有序地流動,創新科技及工業局與國家互聯網信息辦公室於 2023 年 6 月在北京簽署《促進粤港澳大灣區數據跨境流動的合作備忘錄》(《合作備忘錄》),共同推動粵港澳大灣區數據跨境流動的工作。

To foster the safe and orderly cross-boundary flow of data within the Guangdong-Hong Kong-Macao Greater Bay Area, the Innovation, Technology and Industry Bureau and the Cyberspace Administration of China signed the "Memorandum of Understanding on Facilitating Cross-boundary Data Flow within the Guangdong-Hong Kong-Macao Greater Bay Area" ("the Memorandum") in Beijing in June 2023 to jointly promote cross-boundary data flow within the Guangdong-Hong Kong-Macao Greater Bay Area.

《粤港澳大灣區(內地、香港)個人信息跨境流動標準合同》(《大灣區標準合同》)為《合作備忘錄》下有關促進粵港澳大灣區個人信息跨境流動的 一項便利化措施。

The "Standard Contract for the Cross-boundary Flow of Personal Information in the Guangdong-Hong Kong-Macao Greater Bay Area (Mainland, Hong Kong)" ("the GBA Standard Contract") is a facilitation measure under the Memorandum to promote the cross-boundary flow of personal information within the Guangdong-Hong Kong-Macao Greater Bay Area.

本備案指南乃為協助個人信息處理者及接收方根據《粤港澳大灣區(內地、香港)個人信息跨境流動標準合同實施指引》(《大灣區標準合同實施指引》)履行《大灣區標準合同》下的備案手續而制定。《大灣區標準合同》內的術語的定義適用於本備案指南。

Filing Guidelines on the GBA Standard Contract (Applicable to HKSAR)

This Filing Guidelines is formulated to provide guidance for personal information processors and recipients to conduct the filing procedures under the GBA Standard Contract according to the "Implementation Guidelines for Standard Contract for the Cross-boundary Flow of Personal Information in the Guangdong-Hong Kong-Macao Greater Bay Area (Mainland, Hong Kong)" (hereinafter referred to as "Implementation Guidelines of GBA Standard Contract"). The definition of terms in the GBA Standard Contract shall also apply to this Filing Guidelines.

本備案指南**適用於《大灣區標準合同》下的香港合同方**,不論香港合同方 為《大灣區標準合同》下的個人信息處理者或接收方。

This Filing Guidelines applies to the Hong Kong contracting parties under the GBA Standard Contract, regardless of whether they are the personal information processor or recipient under the GBA Standard Contract.

二、備案方式及流程

B. Filing Method and Process

香港個人信息處理者及接收方應在《大灣區標準合同》生效之日(即《大灣區標準合同》簽署日期)起10個工作日內,須向政府資訊科技總監辦公室(資科辦)進行備案。

The personal information processor and recipient of Hong Kong shall conduct the filing procedures with the Office of the Government Chief Information Officer ("OGCIO") within 10 working days from the effective date (the signing date) of the GBA Standard Contract.

Upon the receipt of filing documents from the personal information processor, OGCIO will check the completeness of the filing documents, and issue a filing reference number to the personal information processor that fulfilled the filing requirements within 10 working days. If there is a need to supplement, the personal information processor shall provide the supplementary documents upon request within 10 working days. For overdue supplement of filing documents, the filing procedure will be terminated.

Upon the receipt and checking the completeness of filing documents, OGCIO will issue acknowledgement to the recipient within 10 working days. If there is a need to supplement, the personal information processor shall provide the supplementary documents upon request within 10 working days. For overdue supplement of filing documents, the filing procedure can be terminated.

三、注意事項

C. Points to Note

(1) 跨境提供個人信息的目的、範圍、種類、方式、或者接收方處理個人信息的用途、方式發生變化,延長保存期限,以及發生影響或者可能影響個人信息權益其他情況的,個人信息處理者應當重新開展個人信息保護影響評估,補充或者重新訂立大灣區標準合同,並履行相應備案手續。

If there are any changes to the cross-boundary transfers of personal information in terms of the purpose, scope, categories, means, or the recipient's use and means of personal information processing, or the retention period is extended, or there are any other circumstances that affect or may affect the rights and interests in relation to personal information, the personal information processer shall conduct a personal information protection impact assessment afresh, enter into a supplemental agreement or a new GBA Standard Contract, and conduct the corresponding filing procedures.

- (2) 個人信息處理者及接收方應當對所提交文件的真實性負責。提交虛假文件的,備案將被註銷,並依法追究相應法律責任。
 Personal information processors and recipients shall be responsible for the authenticity of the documents submitted. If false documents are submitted, the filing reference number will be cancelled and the applicant shall be subject to legal consequences in accordance with the laws.
- (3) 為確保有效及迅速的郵遞服務,寄件人需確保所寄的郵遞品已繳付適當郵資。任何未就其繳付適當郵資的郵遞品將不會被派遞至本辦公室,並將由香港郵政根據《郵政署條例》作出處理。 For effective and timely delivery of mail, all senders are required to ensure that their posted mail items are affixed with sufficient postage.
